

# Hammerwich Parish Council Minutes

## 21 October 2020

### 1. Apologies for Absence

Apologies were received from Councillor Thurlow and Ho. Councillor Silvester-Hall, Lichfield District Council (LDC) also submitted her apologies.

### 2. Declarations of Interest

Councillor Grundy declared her husband sometimes worked with LDC officers who the Council used for contracts.

Councillor Ennis and Place declared that they worked with Councillor Loughborough – who had expressed an interest in joining Hammerwich Parish Council, on Burntwood Town Council.

### 3. Approval of Parish Council Minutes held on 16 September 2020

It was noted that Councillor Taylor had requested that her vote against Walsall Burial Park application be recorded in the minutes – Item 10 on 16 September minutes refers. Subject to this addition the minutes were approved.

### 4. Matters Arising

Hedgehog Houses The Triangle

It was agreed that the request for hedgehog houses on the Triangle should be approved.

The Chairman reported that a wreath had been ordered on behalf of the Council for Remembrance Day and the Chair would lay the wreath in accordance with Covid19 Safety measures

#### **6. Grant Request**

A request from Burntwood Dragons to cover the cost of replacing a broken piece of play equipment (see-saw) had been requested.

**Councillors felt that as this would benefit the local community, they were willing to purchase the equipment and asked the Clerk to arrange this purchase directly. This would then be a Council asset along with the other playground equipment at Hospital Road.**

#### **7. County/District/Police Reports**

##### Councillor Smith (SCC)

Councillor Smith discussed the recent flooding at the railway bridge.

He welcomed the fact the road was being swept more frequently by LDC following a request from Hammerwich Council and noted that a gully cleaning request had been submitted to SCC Highways.

Councillors discussed the possibility of a depth measure at the side of the bridge so that vehicles were aware of how deep the water was.

He reported that a donation from SCC Covid funds had been made to Hammerwich Cricket Club.

He was aware of the Council's proposals regarding speed indication devices and supported this project.

### SID Devices

Councillor King presented a detailed presentation regarding options for Speed Indicator Devices (SIDs)

**Councillors resolved to**

- a) Approve message maker as the supplier of the SIDS;**
- b) Ask Councillor King to work with the Chair and the Clerk to progress the necessary paperwork for this project;**
- c) Ask Councillors to vote on their preferred display for the SID device by email;**
- d) Agree that 4 posts 2 SIDS be purchased;**
- e) Agree a budget of £7k for this scheme; and**
- f) Ask Councillor King to inform local residents, who live near where the posts will be positioned, of the Council's proposals.**
